

# Monthly Education Lecture-June 2023

#### THE COWEN

Definition:

Noun – (plural cowans) A worker in unmortared stone; a stonemason who has not served an apprenticeship. A person who attempts to pass himself as a Freemason without having experienced the rituals or going through the degrees. A sneak; an inquisitive or prying person.

Cowan is a Scottish trade term that has come to us from Scottish operative masonry.

In Scotland, the word 'Cowan' denoted "Dry-dyker" – a man who built walls of stones held in position by their own weight and not by mortar. As he did not use mortar or prepared, hew, or cut stones in his trade, he was looked upon as an inferior type of artesian by the operative mason, and as such was denied admittance to a mason's "Lodge", as trade-controlling bodies, they put restrictions against the employment of cowans in order to protect the fully trained men of the Craft from unskilled labor. This official ban against cowans appears during the 16th Century.

These Scottish operative masons, who intended to keep these cowans out, had their Tyler's, who as their name suggest, were those who placed roofing tiles in position after the masons had completed the walls, and from their lofty perch on the roof were charged with the additional task of reporting the imminent approach of cowans. This was intended to give Masons time to band together to keep off the cowans and intruders.

What has speculative Masonry made of the Cowan?

In the early 1700's there are records showing that the early speculative masons were, if anything, more bitterly opposed to the admission of Cowans than even the operative masons had been. As early as 1738 the "Constitutions" laid down that 'no free and accepted Mason shall work with, be employed by, or teach his trade to a cowan. About this time the import of the word cowan underwent a further change, for it came to include any person not a Brother. Before the end of the century, it also applied to the 'eavesdropper one who listened to conversations not intended for his ears.

In 1707, in its ordinance against the employment of Cowans, the Lodge of Kilwinning, in Scotland, described a Cowan as a mason 'without the word' – a member of the Craft without full privileges.

The reason for the inclusion of Cowans in the Masonic ritual begins to become apparent if not entirely obvious, as both Masons and Cowans worked in stone, and although they had entirely different methods of building with the same materials, they were both art forms with similarities.

So, the Cowan, like the stonemason, was an artist in his own right.

No doubt when the local Cowan had no immediate work prospects, and as he was a stone worker or a mason of sorts, why not seek work as a stonemason where there was a church, cathedral, or castle in the course of construction?

And who can blame him, after all, like everyone else he was obliged to earn a living any way he could. However, he was lacking in qualifications.

For instance, he didn't serve a recognized apprenticeship. He had never learned to cut and shape stone according to a prepared plan or drawing. He didn't have a registered journeyman's mark and above all, he didn't know the mason's word. So, the chance of his obtaining employment at any of these places was slim at best, but obviously, it didn't stop him from trying. His prospects of finding work as a stonemason were confounded even further around the end of the sixteenth century, when the Warden General of the Masons of Scotland, a Mr. William Schaw, introduced the first Masonic statutes or regulations governing all Scottish Masons, and at the same time, creating the first permanent Lodges in Scotland.

One of the regulations contained within the statute stated that no Mason shall work with a Cowan. Hence no Cowan was allowed on a work site where stonemasons were employed.

So the phrase "To observe the approach of cowans and eavesdroppers" would mean to disbar any dry-stone wall builders or any other unqualified person from working with the stonemasons on any construction site. This would also prevent the Cowan from joining a Mason's Lodge.

In today's world, with the demise of the ancient stonemason's trade, as well as the dry stone building work of the Cowans, in practical terms, the rule doesn't apply anymore.

However, as a part of that unique teaching tool that we refer to as the ritual, it remains an essential ingredient. And so brethren, although we have nothing to fear from Cowans, we are still going to keep them out.

## A Message From Past Master Mathew McCarthy

SV LODGE #57 Delivers...Again By Matt McCarthy, PM

#### SANDY VALLEY, NV

On July 26<sup>th</sup>, 2023, Brothers from Sandy Valley Lodge #57 delivered three truckloads of dry, self-stable pantry food items to the Keystone Pantry in Sandy Valley.

In early 2020 there was not a non-profit food pantry to be found in Sandy Valley. Families experiencing food insecurity had few places to turn. Recognizing a community need, Lisa and Sarah started the Keystone Pantry. For some time they served approximately 30 families. However, once the COVID pandemic hit, the number of families experiencing food insecurity grew exponentially. According to Lisa, "The number went from 30 to 60 and up."

Today, Keystone Pantry provides approximately 165 families with nutritional food through a drive-thru style delivery method. Moreover, volunteers make home deliveries to 25 homebound seniors and support an additional 30 seniors at the Sandy Valley Senior Center. When asked how frequently food is disturbed at the pantry and throughout Sandy Valley, Lisa said, "Weekly".

With only a small but generous grant, Lisa and Sarah rely on donations to stock the pantry. Three Square, The Church of Jesus Christ of Latter Day Saints, and Sandy Valley Lodge #57 are key to providing food essentials to those whom Keystone Pantry Serves.

For this particular delivery, Brothers Carl Agbayani (*Senior Deacon*), Michale Kearns (*Junior Warden*), and Matt McCarthy (*PM*) traveled to Indian Springs Lodge #48 where Celestial Manna has its food pantry (*Established in 1989, Celestial Manna provides meals to food-insecure families throughout the country*.). While waiting for volunteer Erin Koch to arrive, the Brothers spent time catching up and noting how much cooler Indian Springs was to Las Vegas (100 degrees compared to 110 degrees).


Soon enough, Erin and another volunteer arrived. With fans whirling, Erin quickly gave orders on what was to stay in the pantry and what was to be sent to Sandy Valley. "All of the items on this shelf from here to here can go," she said. "And these boxes can go, too," she said, pointing to a tack of canned green beans. Battling the heat, Brothers stacked boxes of canned vegetables and canned fruit, along with other dinner sides, onto dollies. Sacks of various grains were tossed into a shopping cart. All of it was then loaded into the back of each Brother's truck.


After thanking Erin for her generosity and making available so much-needed food, the Brothers headed to Sandy Valley to meet up with the Keystone Pantry founders Lisa and Sarah. Upon their arrival, they were met by a cadre of volunteers, some ranging between the ages of 11 to 13. With a sense of quickness, the trucks were offloaded and what was a relatively bare dry storage room was quickly filled with much-needed food items.


For how long will this food last?
