The Master's Goals for 2025

RECRUITMENT.

- Work with the Sandy Valley Officers, all Sandy Valley brothers, and the Grand Lodge of Nevada on a recruitment
 program. It is critical that we involve our younger members in this process and give them advice on how best to
 promote freemasonry to their peers.
- Work with our youth group committee chairman to schedule a time to visit with the DeMolay youth as part of the
 month of the Grand Lodge's March youth groups. It is critical that these young men see that Masons are interested
 in their group and what they are working for. This will also allow us to talk to these young men and give them
 advice on how to best recruit members to their organization.

RETENTION.

- Work with the entertainment committee to set up at least two social events this year. Those events would be open to all brothers, their families, and any guests they wish to invite.
- I would like one of these events to be fun, such as going bowling. The other event I envision doing is one that honors all the past masters of Sandy Valley Lodge No.57. They have been a vital part of the lodge's development, and I want to honor their commitment to the lodge and Masonry.
- Work with the leadership of our brothers in Pahrump Lodge No.54 to beautify the areas of the lodge that Pahrump Lodge No.54 has given to us. For instance, post pictures of all this year's Sandy Valley officers. Also, please post photos of all our past masters to honor them.
- Most importantly, perform timely degrees for the candidates and brothers going through the various degrees. It
 is essential that we don't fall behind in this process. When we do, we can often lose perspective, Master Masons.
 My goal is that no one should wait more than two months before being elected to take the degrees or pass a
 proficiency before moving on to the following degree. Of course, this will take a concerted effort from the team.
- Finally, work with the brothers completing their degrees to pass their various proficiencies. We all have the
 responsibility to offer this assistance. However, the primary persons who should be driving this are those brothers
 who are first—and second-line signers.

RE-ENGAGEMENT.

Formulate a process to reach out to those members we don't see often at meetings. While their dues are vital, it is even more vital, in my opinion, to have a lodge where more members participate in the stated meetings, degree work, and social functions. Find out those members' barriers to participating in meetings and work with those brothers to find ways to eliminate those barriers.

EDUCATION, DEGREE CONFERRALS, AND CEREMONIES.

- Take part in all District 11 DGL training opportunities. Dates for these are 1/18/25, 4/19/25, 8/12/2025, and 11/15/2025. These are all great opportunities for learning and improvement. We will also need maximum participation in the Nevada Grand Lecturers workshop date to be announced.
- Work with appropriate committees to set up team members to take roles in the various degrees of masonry, especially the Master Mason degree's second section. Work with members to learn multiple roles.
- Junior Warden will open/close a meeting of Entered Apprentices and confer an EA degree. Senior Warden will open/close a meeting of Fellowcrafts and confer a Fellowcraft degree.
- Work with appropriate committees to work on our funeral degree. Do at least one practice this year of the funeral degree.
- We will continue conducting monthly education during our stated meetings. My vision is that various officers will take turns performing the monthly education. I will work with the education committee to accomplish this goal.
- We will invite a brother from one of our sister lodges to do one of the monthly educations and offer to conduct education at that lodge when we make an official visit.
- Work with the education and ritual (Hi-twelve Committee) to set up practices for opening and closing a lodge, all
 the various degrees, balloting, and special presentations such as the GMOV.

COMMUNITY INVOLVEMENT AND INVOLVEMENT WITH OTHER MASONIC LODGES.

- We will continue our practice of official visits to other Masonic lodges. We will take that opportunity to learn best practices from our brothers at these lodges.
- Special project that I want us to be involved in. Work with the Grand Lodge of Nevada, Vegas Lodge No.32, and other lodges to do a Table Lodge during the Daughters of the Nile Supreme Session in June. Many Masons from

all over the United States will attend with their spouses. When I attended last year's sessions in Boise, Idaho, the Idaho Grand Lodge and an area lodge hosted a dinner, and the Grand Lodge officers did the second section of a Master Masons degree. I want to do the same here in Nevada.

Additionally, work with the Entertainment Committee to try to set up a joint summer function involving as many
area lodges as possible. My suggestion would be a picnic lunch and lawn games. Invite as many brothers, family
members, and guests as possible. Show everyone that Masons like to have fun.

CHARITABLE ACTIVITIES.

- We will continue to provide food donations to the Sandy Valley Food Pantry and work with the Charity Committee to develop a plan for at least one donation this year.
- Assist the Sandy Valley food pantry by volunteering at least one Friday a month this year to help hand out food to those who need it.
- Work with the Charity Committee to consider raising funds to buy turkeys to hand out at the Sandy Valley Food Pantry in November 2025.
- Work with the Charity Committee to discuss how we can assist the Sandy Valley Activities Center. This is a center
 where area kids can go after school. When I asked how Sandy Valley could help, they told me we could provide
 recreation equipment such as soccer balls, etc.
- We will continue to work with the Scholarship Committee to award deserving students the George Odell Scholarship.

FINANCIAL SECURITY.

- Work with the Finances Committee and the Trustees to set up appropriate tax-deductible opportunities for Sandy Valley Lodge. This may be a way for members to contribute to Sandy Valley Lodge as a tax-deductible item.
- Work with the Finance Committee and the Trustees to see if there are any opportunities to invest our monies in
 investments that might earn us more capital. Of course, we must do this within the bounds of the Nevada Masonic
 Code.
- Work with Pahrump Lodge No.54 leadership to try and set up a fundraiser to assist in building maintenance, security, and beautification.

APPENDANT BODIES.

- We will continue to have the members of the Appendant Bodies Committee report on various activities occurring at those bodies.
- As stated before, participate in as many youth events as possible. Invite youth group members and appendant body leadership and members to any social events we plan.
- If possible, pick a time for appendant body leadership to visit a Stated meeting and talk to us about their various activities and opportunities.

Monthly Education Lecture, Part 1-February 2025

NV Grand Lodge Short Lecture Series

GEORGE WASHINGTON AND THE U.S. CAPITOL CORNERSTONE

This month our lecture covers George Washington and his role in laying the cornerstone during construction of the U.S. Capitol in Washington, DC. The cornerstone was laid on Wednesday, September 18, 1793, during the first large public event staged in the federal city. A Georgetown newspaper accounted the event, citing a rather large procession of Maryland and Virginia masons led by George Washington marched from President's Square in Washington DC until they reached the location of the capital. Once there they formed a circle around President George Washington, who, wearing the Masonic apron (made for him by the wife of his fellow American Revolution General Lafayette), was served as one of the honorary leaders over the ceremonies.

A silver plaque, fashioned by Georgetown silversmith Caleb Bentley, was handed to Washington, who stepped into the foundation trench and placed the plaque, whereupon the cornerstone was lowered. The plaque was inscribed the following: This South East corner stone, of the Capitol of the United States of America in the City of Washington, was laid on the 18th day of September, in the thirteenth year of American Independence, in the first year of the second term of the Presidency of George Washington, whose virtues in the civil administration of his country have been as conspicuous and beneficial, also his military valor and prudence have been useful in establishing liberties, this is place here in the year of Masonry 5793, by the Grand Lodge of Maryland and Lodge 22, from Alexandria, Virginia.

Washington accompanied the Most Worshipful Joseph Clark, Grand Master of Mason in Maryland and by three Worshipful Masters who carried corn, wine, and oil, then struck the stone three times with a gavel, as prescribed by Masonic custom. Washington exited the trench to ritual chanting by the assembled Masons and a 15-gun salute (one gun for each U.S. state) from the Alexandria Volunteer Artillery. Most Worshipful Clark then delivered a short invocation, after which a 500 pounds (230 kg) ox was slaughtered and roasted. Though some anti-masons would later deny the event as ever occurring, it was document and witness by many observers and reporters.

The Missing Cornerstone

Today, we do not know exactly which southeast corner is being described by report accounts of the event, whether that meant the southeast corner of the Senate wing, the first section of the building to be completed, or the southeast corner of the whole building as intended, which would locate it over on the House side. More than two centuries later, the Architect of the Capitol is still searching for that cornerstone. Metal detectors have failed to locate the silver plate.

Regardless of where the cornerstone may be found, the significance of masonry's role in America, was apparent in the personal interest that George Washington and other federal leaders took in this building and proclaiming such an event to all, and they were conscious of creating a republic amid a world of monarchies, and they turned to the ancient Roman republic as a model.

In addition, the federal leadership renamed Jenkins Hill as Capitoline Hill—soon shortened to Capitol Hill. On the draft plans for the city, Thomas Jefferson also crossed out "Congress Hall"—as the meeting place for Congress was called in Philadelphia—and wrote "Capitol" instead. At the time, the federal government was situated in Philadelphia, a city of brick, but Washington wanted a classical style for the new capital city that would be named for him, with buildings constructed in stone.

G. WASHINGTON, "THE WIDOW'S SON"

The life of George Washington and the introduction of Masonry into America is remarkably concurrent. Washington himself entered this world on February 22, 1732, and the first Masonic lodges appeared in the following year in Boston, Philadelphia and Charleston, SC. He was a true "widow's son" his father having died when he was but 11 years old and his mother superintending his early education.

Even in his boyhood he is said to have manifested a military taste and to have exerted a commanding influence over his youthful associates, and by the age of 19 he had achieved the position of Adjutant General in the Virginia Militia. Such he'd already achieved when at the age of 20 he first offered himself to Fredericksburg Lodge as a candidate for the mysteries of Masonry. He was initiated on Nov. 4th, 1752, passed on March 3rd, 1753, and raised to the sublime degree on August 4th, four months later. In November of that same year, he was commissioned by the Governor of Virginia to journey to Ohio and demand, in his name, that the French relinquish and depart the territory, and cease to intrude what was considered England's domain. This of course the French refused to do. Following his return to Virginia and upon the death of his commanding officer, Colonel Fry in 1754, Washington was placed at the head of Virginia's troops. His first lessons in active military life were direct experience, for he had few to council and none to guide him. His campaign was short, ending in July of that same year with his capitulation to the French at Fort Necessity. This marks the only time in his life when he ever struck his flag to a foe.

Of his first six years as a Mason, five of those were spent in conflict, and thus his attendance in his own lodge in Fredericksburg was infrequent, but tradition states that Washington and his Masonic brethren held Military lodges during the war, and there is a cave near Charleston, Virginia which is to this day referred to as Washington's Masonic Cave. It is divided into several apartments, one of which is called "the lodge room" and it is said that he and his brothers held their lodges here.

After the war, he took a seat in the Colonial Assembly of Virginia, and in the same month, married Mrs. Martha Custis, a wealthy and accomplished widow whose ample fortune enabled them to maintain a style of living equal to Virginia gentlemen of the first rank of society. The next 15 years of his life were spent in domestic retirement, interrupted only by his public duties as a member of the Colonial Assembly, and his duties as Master of Alexandria lodge #22, near Mount Vernon.

Then, in 1774, when the clouds of political adversity were gathering above our country, a congress of delegates was convened in Philadelphia, to which Washington was a representative of the State of Virginia. The conflict had already begun at Lexington and Concord, and Washington was elected as Commander-in-Chief of the American Army. He was 43. On the same day, in Boston, the Battle of Bunker Hill was fought, and American Masonry lost General Joseph Warren, Grand Master of Massachusetts in the battle. This was the first grand sacrifice of Masonry at the altars of liberty but would not be the last.

On taking command of his army, one of Washington's chief duties was to provide for the comfort and necessities of his troops. At this time a movement was begun to establish a Masonic lodge in the camp. They applied for and received dispensation from the Grand Lodge of Massachusetts, and the American Union Lodge was formed. Tradition holds that

Washington attended often, though the loss of their records prevents us from verifying this, with the notable exception of the Feast of St. John the Evangelist, held on December 28, 1777, the record of which still exists and bears his name. In 1780, however, an attempt was made to unify the colonies into one Masonic Grand Body, and specifically named General George Washington as the first General Grand Master of Masons of the United States of America, but this attempt was put off until such time as "a general peace shall happily take place throughout the continent". This concept never gained traction, and independent Grand Lodges formed within each state, similarly to the political independence held by states in the early days following the revolution. From this action arose, undoubtedly, the wide-spread appellation of the title of General Grand Master for Washington, which, though a historical error, has not yet been eradicated from the minds of the public, or of many Masons, a Myth made stronger by the fact that almost every Masonic jurisdiction in America today has at least one lodge bearing to his name, and that many dedicated their first Book of Constitutions of Grand Lodge of England editions to him.

Upon his death on December 14th, 1799, just days before the turn of the new century, he was buried with Masonic honors, and lodges throughout the country held Lodges of Sorrow during the entire month. A Golden Urn containing a lock of his hair, along with his Masonic apron and regalia are on display at the Grand Lodge of Massachusetts, where he was first made a Mason, and though he held no Masonic office, other than that of Past Master of his lodge in Alexandria, Washington is and ever shall be regarded as the great patron of American Freemasonry.



I have included instructions for GrandView access for your convenience.

For those of you still needing assistance signing up with GrandView, I have included the instructions below.

GrandView Instructions: From your browser, type in nymasons.org. Once the page opens, click the resource link in the upper right-hand corner using the dropdown menu. Click on Grandview and follow the instructions listed below.

- 1. Please read the following instructions; the registration link is at the end.
- 2. Enter the information carefully:

a. Lodge Number:

Enter home/primary NEVADA lodge number only. ONLY numeric characters. For example, if you were a member of Lodge #3, enter a 3

b. Member ID:

This should be the number in the corner of your current dues card.

c. Last Name:

Enter last name (CASE SENSITIVE). Most names are capitalized in the common fashion. If your last name has multiple capitals or names, you may have to try other combinations of capitals. For example, try "Mcc" and "McC". If you have several last names, try the very last one first.

d. Hit "Check Membership Status"

3. If successful in verifying membership, it will prompt you for an email and password set-up.

a. Email:

Please use a personal email that you would like the Grand Lodge to use as a contact for you. DO NOT use a lodge email as "Secretary" status is granted in the system (i.e., choose an email that will stay with you, not your position.)
